SUMMARY STATEMENT:

The resolution of intent to form a Lake Management District was passed by the Whatcom County Council July 9, 1991. During the month of December a mail ballot was conducted. Property owners voted on the creation of the District. The vote to form the District was affirmative with 53,751 votes in favor of creation and 8,930 opposed. About 58% of the property owners returned their ballots (221 of the 380 property owners) with 86% of those voting affirmatively.

This ordinance formalizes the creation of the District.

ORDINANCE NO. 92-006

AN ORDINANCE CREATING A LAKE MANAGEMENT DISTRICT FOR LAKE SAMISH, DESIGNATED AS WHATCOM COUNTY LAKE MANAGEMENT DISTRICT NO. 1

WHEREAS, Chapter 36.61 RCW authorizes the Whatcom County Council to initiate the creation of lake management districts; and,

WHEREAS, the Whatcom County Council found the creation of a lake management district for Lake Samish to be in the public interest through adoption of Resolution 91-051; and,

WHEREAS, the proposal to create the District received a majority of the votes cast by property owners within the proposed district pursuant to RCW 36.61.080 - 36.61.100.

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that the Whatcom County Lake Management District No. 1 (Lake Samish), as proposed in Resolution 91-051, adopted on July 9, 1991, is hereby created.
